School Expense Allowance

This allowance is for supporting families who have financial difficulties with paying for expenses associated with their children's school supplies or lunch fees.

1. Recipients

Families that meet the three points below can apply for the allowance:

- Those who live in Oyama (City),
- Those who have children that currently attend elementary, junior high or a compulsory education school (ES/JHS/CES) located in Oyama (City),
- Those who are <u>under livelihood protection</u> (recipients), or whose financial situation is considered to be as difficult as recipients and are found to be in need of support by the Board of Education (potential recipients).

(Criteria for recognition of potential recipients)

The Household income for the previous year was below 1.2 times of the base amount needed for livelihood protection.

- * Household here means everyone who is dependent upon the income provider(s) whether they are registered as a family member or not.
- *The base amount needed for livelihood protection depends on the number and age of family members and whether you pay rent on your residence or not.
- *Loans (such as mortgages) will not be taken into consideration.
- If you change from a renter to a house owner, the base amount of this allowance will be reduced and approval may be cancelled (It does not mean that house owners cannot be approved).
- *After application, your household income in the previous year will be investigated. If you have not done an annual adjustment at your work place, please declare your income.
- *The income of all the members in your household must be declared.
- ●Indications of eligible incomes for (receiving) the school expense allowance

^{*}Because this allowance will be paid through the school, please confirm with them when and how you will get the allowance.

*If your application is approved in the middle of the financial year, you will be paid from the month that you are approved. *Not all school expenses are covered by this allowance.

3. Application

If you would like to apply for the allowance, please fill in the "School Expenses Allowance Application Form" and submit it to the school your children are currently attending (You can get the application form from your school, the Board of Education or through the Oyama City homepage).

- *Those who were approved for the allowance for the previous financial year are required to re-apply each year.
- *After your application is received, a local case worker may visit your house talk with you (This may not occur for all of the applicants. If you are chosen, we will let you know in advance).

«Application submission deadline» April 30nd (Wed.) 2025

- *Applications will be processed on the 1st of the month in which they are submitted.
- **Successful applicants will be notified by their school after June. The first payment for this financial year will be after July.

4. Other

If your household or financial situation changes after the approval of this allowance and you do no longer require it, please notify your school immediately.
